Town Board Meeting Minutes Monday, June 6, 2022 7:00 PM

Call to Order- Chairman Mark Gunn called the monthly board meeting to order with all board members present.

Approval of Minutes- Supervisor Parker moved to approve the minutes for May 2, 2022 (with the stipulation they be amended), May 10, 2022, and May 26, 2022 (with the stipulation they be amended). Second by Supervisor Dubanowich. Motion carried with a voice vote.

Treasurer's Report- Supervisor Parker moved to approve the Treasurer's Report as presented. Second by Supervisor Dubanowich. Motion carried with a voice vote.

Zoning Officers' Report- Dave Diestler gave his report. Attorney Lindau also gave update on court proceedings for the Robert Rebout property at 4931 South County Road D.

Planning and Zoning Report- Tony Dubanowich gave his report.

Audience Communications- 1) Glen Van Buren, 3715 Fifth Street, requested that it be considered to move the "Dead End" sign for Fifth Street closer to the corner of Fifth Street and County Road D. Chairman Mark Gunn said that he will look into this. 2) Ryan Frye, 6207 County Road D, questioned how to request a variance for a larger garage. The Board suggested he attend the Planning & Zoning meeting at the end of the month.

Deputy Bordner from the Rock County Sheriff's office spoke to the townspeople, and asked if there currently were any concerns in the town. Supervisor Parker asked to have officers monitor the park on a regular basis.

Consider and Act Upon Bipartisan Infrastructure Law (BIL)- Attorney Michael Davis gave update. Four applications were submitted by the June 3rd deadline (Johnson Road, Hanover Road, Kessler Road, Plymouth Church Road), with the Town of Beloit in the lead on a fifth application (Townline Road).

Consider and Act Upon iWorq Statement and Future Services- Bill Kienbaum feels the iWorq services have been a great asset for the town. The town will continue service for now, including the premium data package, and rediscuss at budget time for next year.

Review and Possible Action on Current Driveways and Maintenance Contract for Mowing of the Town of Rock Cemetery- There is an ongoing issue with people driving through parts of the Cemetery that are not meant to be driven on. Chairman Mark Gunn will talk to Mike Smith about the possibility of pulverizing the ground that has been damaged by vehicles, and Supervisor Dubanowich will look into putting signs up in those areas to help prevent people from continuing to drive on them.

Consider and Act Upon the Appointment of a Deputy Clerk/Treasurer- Supervisor Parker moved to appoint Deb Bennett as Deputy Clerk/Treasurer. Second by Supervisor Dubanowich. Motion carried with a voice vote.
